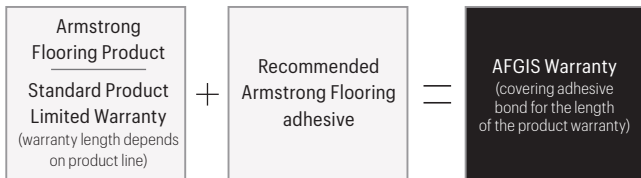


# Armstrong Flooring Guaranteed Installation System & Strong System™ Limited Warranty

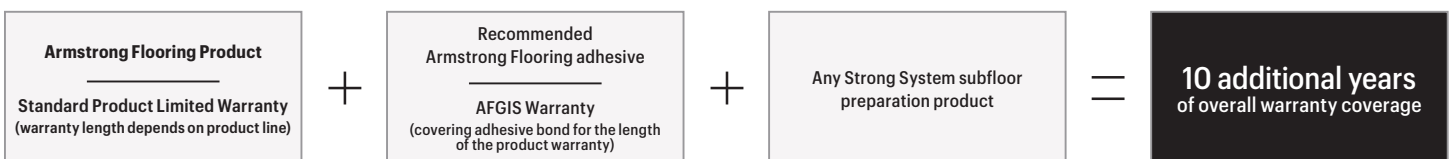

## The Strong System Limited Warranty

The installation of an Armstrong Flooring product along with the recommended Armstrong Flooring adhesive, as well as any one of the Strong System subfloor preparation products listed above, provides 10 additional years of limited warranty coverage. The Strong System limited warranty covers the installation integrity for the length of the flooring product warranty plus 10 years. In order to qualify for the Strong System Limited Warranty, any subfloor preparation product needed for an installation must be an Armstrong Flooring product.

When Armstrong Flooring Strong System subfloor preparation products are used with other manufacturers' floor coverings, adhesives, or other subfloor preparation products, Armstrong Flooring warrants our products to be free from manufacturing defects from the date of purchase through the limited warranty period of 15 years.
